Good morning! There's less than a month left before the Iowa GOP caucuses, kicking off the 2024 Republican presidential nominating cycle.

- Though it's still possible for another candidate to get a last-minute surge, former President Donald Trump has strengthened his lead in early state polls, according to aggregated data by FiveThirtyEight.
- Poll analysis <u>from ABC News</u> found that historically, presidential candidates with at least 40% in December national polls go on to become their party nominee.
- But others like Florida Gov. Ron DeSantis say they will be able to overtake Trump in states like Iowa and New Hampshire. <u>The New York Times reported</u> that DeSantis said Trump will claim the Iowa caucuses were "stolen" if he loses the first-in-the-nation contest.

How a new way to vote is gaining traction in states — and could transform US politics

With U.S. democracy plagued by extremism, polarization, and a growing disconnect between voters and lawmakers, a set of reforms that could dramatically upend how Americans vote is gaining momentum at surprising speed in Western states.

Ranked choice voting, which asks voters to rank multiple candidates in order of preference, has seen its profile steadily expand since 2016, when Maine became the first state to adopt it. But increasingly, RCV is being paired with a new system for primaries that advances multiple candidates, regardless of party, to the general election. Proponents argue these twin reforms deliver fairer outcomes that better reflect the will of voters, while disempowering the extremes and encouraging candidates and elected officials to prioritize conciliation and compromise. Sec. of State Bellows hears arguments for and against challenges to Trump's ballot eligibility

Mainers who filed challenges to former President Donald Trump's primary election eligibility say putting him on the ballot would violate two amendments of the U.S. Constitution, the 14th and 22nd. Counsel for Trump says only one section of the Constitution matters — the three qualifications for the presidency.

The challengers presented their arguments on Friday to Maine Secretary of State Shenna Bellows, who is expected to issue her ruling later this month. The hearing also sought to answer the question of whether Bellows, who served as presiding officer over the hearing, has the authority to rule on the challenges, a power objected to by Trump's counsel. | Maine Morning Star


